The School is required to apply on online for further extension of affiliation

2. along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws, 2018.

The school will also abide by the conditions prescribed, if any, by the State

3. Government concerned as mentioned in certificate as per appendix III issued by District Education Officer (DEO) /equivalent officer

The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning in way of

4. curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.

The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there of for reference purpose and also advised to visit

The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances. The school must strive to promote conservation of environment on their campus through rain water harvesting, segregation of waste at source,
- recycling of organic waste, proper disposal of waste including electronic waste, use of energy saving and energy efficient electrical equipment, greening of campus, use of solar energy, education and awareness amongst children on environment conservation and cleanliness etc

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.

Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while

14. granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.

Running of coaching institutions in the school premises in the pretext of

15. providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.

 - The school shall also maintain record of certificate, compliances, data and other records/information and shall be fully responsible to produce all such records before Board and appropriate Government Authorities when asked for,
- failing which necessary action shall be taken as per Affiliation-Bye-Laws of the Board. The school shall also be liable for action by the appropriate Govt., in case of violation / non-compliance of the concerned Govt. norms
- The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.
